Please take notice that the Planning Commission of Porter Township will hold a public hearing at the Porter Township Hall, located at 4029 S. 9 Mile Road, Breckenridge, MI 48615 on **Thursday**, **April 8, 2021, at 7:00 PM**, in accordance with PA 110 of 2006 (Michigan Zoning Enabling Act). The subject of the hearing will be amendment of the Special Use Permit for a Wind Energy Facility approved by the Planning Commission on November 10, 2020 to include erection and operation of a temporary concrete batch plant on a parcel located at the corners of Redstone and Meridian Roads associated with Parcel ID: 150-025-400-100-00 and street address 30 W. Redstone Road, Merrill, MI 48637. The Planning Commission will also consider a request to amend the approved site plan associated with the Wind Energy Facility to move the location of Turbine 29 approximately 200 feet along with movements to related improvements.
